


2024 ADEPT (Achieving Diabetes Equity Practice Today)

- 1. What are the dates/times of ADEPT?
 - a. Tuesday November 12, 7am-5pm (CST) and Wednesday November 13, 7am-1pm (CST)
- 2. Do I have to book my own flights?
 - a. Yes, you will need to book and purchase all transportation to and from ADEPT?
- 3. When should I fly into Chicago?
 - a. Since we will be starting early on Tuesday November 12th, we recommend flying in Monday evening November 11th.
- 4. Where will ADEPT take place?
 - a. ADEPT will held in Chicago, II, hosted at the Chicago Marriott Downton Magnificent Mile (540 Michigan Ave, Chicago, IL 60611)
- 5. .Where can I find the agenda?

- 6. What costs are being covered by T1D Exchange?
 - a. Breakfast and lunch on Tuesday November 12 and Wednesday November 13 for all attendees.
- 7. What costs are not being covered by T1D Exchange?
 - a. Registration
 - b. Flights
 - c. Taxis, gas mileage, parking
 - d. Meals/Snack outside of meals provided.
 - e. Hotel rooms
- 8. Do I need to register?
 - a. Yes, we ask that you please submit your registration on the ADEPT website using this <u>link</u>.
 - b. Please submit one reservation for each attendee by **October 10th, 2024**.
- 9. Do I have to book my own room?
 - a. Yes, we ask that you book directly though the hotel on our event page using this <u>link</u>.
- 10. How do I know if my room with the hotel is really booked
 - a. You will receive confirmation with the hotel before the Learning Session





- 11. Can I add extra nights before and after ADEPT?
 - a. Yes, please indicate that when you book your rooms with the hotel using this <u>link</u>.
- 12. How many team members are allowed to join ADEPT?
 - a. Centers may bring as many team members as they would like, just be reminded all costs are paid by centers/individual.
- 13. Will there be CME/CEU for ADEPT?
 - a. There will be no CME/CEU credit offered during this year's session.
- 14. Can some of my team join ADEPT virtually?

- 16. If I am staying for the ADEPT after the Learning Session conference what is covered?
